## Educational Opportunities Available

Memorex is growing so fast that there are numerous promotional opportunities for employees who want increased responsibilities and challenges. Recognizing that your personal growth is as important to the Company as it is to you, we offer you the chance to participate in a number of training programs. A large new Education Center has also been constructed in the building which faces the main cafeteria on Shulman Avenue.

In addition, employees who enroll in approved courses from accredited institutions may qualify for financial assistance from the Company. The questions and answers which follow explain the reimbursement program.

### Who is eligible for a reimbursement?

- Every full time Memorex employee who has completed six months of employment **before he applies** for enrollment in a course of study.

### Which courses are reimbursed?

- All courses that relate directly to maintaining or improving the effectiveness of your current job are reimbursed 100%. For example, shorthand for secretaries, accounting for accountants, mathematics for engineers.
- All courses that indirectly relate to your job (supportive skills) such as cost accounting for engineers, financial analysis for managers, or English composition for secretaries are reimbursed 50%.
- All courses which you take as part of a "Memorex Career Development

Plan" will be reimbursed 100%. This plan must be jointly prepared by you and your manager. It must state your career objectives, outline your planned course of study, and be reviewed by Manpower Development and Planning.

### What do I do first?

- 1. Get an application form and fill it out **before** the class starts.
- 2. Take the completed form to: Dick Doherty, IMG Manpower Development Manager or Bill Stevenson, MEG Manpower Development Specialist
- 3. Your request will be processed and you will be notified in writing of approval or disapproval for reimbursement. A copy of the application form will be returned to you—save it.

### When will I be reimbursed?

- 1. When you've completed the class take your grade slips, all receipts for expenses, and the copy of your original application form to Dick or Bill.
- 2. If everything is in order a check request will be issued to Accounting and you will be reimbursed.

### What happens if I fail the course or withdraw?

- 1. If you withdraw before a grade can be issued or if a grade of "C" (or its equivalent) is not obtained, you will **not** be reimbursed.
