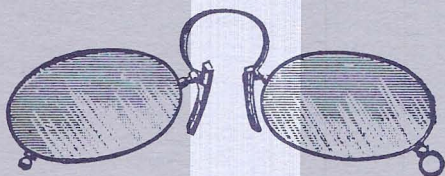


More Adult Ed Courses Begin Nov. 16



Below is a list of courses that will be given in the Education Center by the Metropolitan Adult Education Program beginning the week of November 16th.

Personnel Management 1A

A study of the problems of supervising and managing people. Case problems are used to involve the student in personnel management decision making.

Course begins November 16th, (Monday) for 9 weeks, 7:00 p.m. to 10:00 p.m.

Effective Communications 2A

A study of the problems of communication in business from a supervisory or management point of view. Oral and written communications are studied as they apply to the problems of managerial or supervisory control.

Motivation Techniques 1A

A study of motivation with emphasis on the

concepts of needs, drive and emotion. Areas covered include motivation of leader-follower, current methods of job motivation and enrichment, and ways of increasing productivity through job enrichment.

Personal Development

Emphasis on effectively presenting oneself. Grooming, posture, weight control, makeup. Women only.

S&I Plan Participation



If you did not join the Savings and Investment Plan when first eligible, you may do so by completing an application and returning it to your Personnel Office before December 1st. If you are a member and wish to change the amount of your contribution, you too must complete a form and meet the December 1 deadline.

Changes of percentage apply for a minimum of six months and begin January 1. Members of the Plan may invest 2, 3, 4, or 5% of their gross pay (total pay before taxes, but not including overtime, premiums, or bonuses).

Members also have their choice of investing in Memorex Stock, U. S. Government Se-

curities, or half in stock and half in securities. The Memorex contribution—fifty cents for every dollar contributed by a member—is always invested entirely in Memorex Common Stock. Members can change the way their own contributions are invested. Changes in investment commence January 1 if forms are turned in to Personnel before December 1.

If you are already a member of the Plan and don't submit any changes by the December 1 deadline, your present investment choice and percentage deposit rate will continue to be used.

Nominations for MAG Board

Semi-annual nominations for the MAG Board of Directors must be submitted on or before November 19th. All employees in the Santa Clara area (with three months of service with Memorex) are eligible to be nominated, and to make nominations. Nomination forms are available now in the cafeterias or from Bill Fullendorf, 987-2992. They should be sent to Diane Leszcz, MAG secretary, at Shulman Avenue.

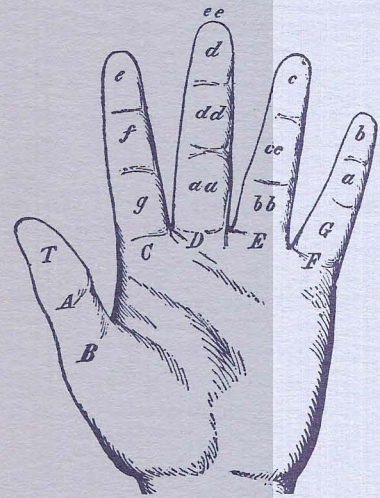
Six places are open on the 12-man Board. The six present members who will remain on the Board are:
